#### NORTH CAROLINA STATE UNIVERSITY PESTICIDE SCHOOLS

You can also visit <u>www.pesticidemanuals.com</u> to register for Pesticide Schools or purchase manuals with a credit/debit card. Credit/debit card payments **cannot** be made over the phone or at the Pesticide Schools.

### 1) Registering For a Pesticide School:

- Fill out the form on the next page and select the subcategory class(es) you plan to attend. You won't be able to attend second day classes with concurrent or overlapping times.
- Enclose your school payment of either \$40.00 for Commercial Applicators or \$20.00 for Private Applicators (Farmers). Checks must be made payable to N.C. State University.
- Mail in the form on the next page with your payment to the address listed above the school dates. Please submit this form at least two weeks in advance if possible.
- If you are unable to attend a school, but have paid, you can transfer to another school for up to one year.
- MANUAL ORDERS: The cost of the manuals are separate from the schools. Orders for manuals cannot be placed over the phone and if you opt to mail in an order form it should be submitted at least three weeks in advance to ensure a timely arrival and give you time to study. - FOR STRUCTURAL PESTICIDE APPLICATORS: You must be a Registered
  Technician BEFORE applying for a Structural Pest Control Certification. Mail the form
  on page 7 in your Structural Manual to the NCDA&CS at least 10 days prior to the test
  date. Questions regarding Structural Pest Control regulations should be directed to
  Victor Lennon, NCDA&CS (919-733-6100).

#### 2) At the School:

- Classes start at 8:30 a.m. On the first day we will cover the Core Manual material. This
  material is for those taking the Core Exam or for Private Applicators (Farmers) who will
  be taking the Private Applicator Exam.
- If you've sent in your payment and have your study manuals, all you need to do on the
  first day of the school is pick up your school agenda and forms on the Welcome Table
  and be seated. You DO NOT have to check-in unless you haven't paid for the school
  or if you need a manual.
- Sub-category classes will be covered on the morning of the second day of the school, before the exams. Again, you may only be able to attend one sub-category class.
- All exams are given on the second day of each school at 1:00 p.m. \*\*Exam fees do apply and fees should be paid to the North Carolina Department of Agriculture & Consumer Services at the pesticide school. \*\*

#### 3) Pesticide Exams:

 All exams are given by the North Carolina Department of Agriculture and Consumer Services. Exam fees differ from school fees so you will be paying the NCDA&CS Inspectors at the school for your tests. Credit card payments will not be accepted on site.
